A Coordenadoria de Assuntos Internacionais (CAINT) da Universidade Federal de Ouro Preto (UFOP) institui o presente edital para indicação de 1 (um) estudante de graduação para participação no Programa "2020 Study of the U.S. Institutes (SUSI) for Student Leaders".

1. DISPOSIÇÕES GERAIS

- **1.1** O "Study of the U.S. Institutes (SUSIs) for Student Leaders" é um programa de intercâmbio acadêmico e profissional para estudantes, educadores e pensadores de todo o mundo. O programa é acolhido por instituições acadêmicas de todos os Estados Unidos, por um período de 5 a 6 semanas, e inclui uma hospedagem acadêmica intensiva e uma visita de estudo educacional integrada.
- **1.2** A bolsa SUSI tem como finalidade promover uma melhor compreensão da cultura dos Estados Unidos, do seu povo e das suas instituições, através do intercâmbio entre os estudantes, professores e acadêmicos estrangeiros. As atividades extracurriculares culturais e comunitárias, neste programa, ajudam ainda a ampliar a compreensão dos participantes sobre a sociedade norte-americana.

2. BENEFÍCIOS

- **2.1** Participação em curso intensivo de 5 semanas, entre 11 de janeiro e 15 de fevereiro de 2020, que consistirá em discussões em seminários, leituras, apresentações em grupo, palestras, acompanhadas de viagens educacionais, visitas guiadas, atividades de liderança e oportunidades de trabalho voluntário com a comunidade local.
- **2.2** O Departamento de Estado dos Estados Unidos da América será responsável por cobrir os custos de todos os participantes, incluindo a administração do programa, voo doméstico e transporte terrestre, material didático, além dos custos com atividades culturais, moradia e subsistência.
- **2.3** O Institute for Training and Development (ITD) será responsável por providenciar e pagar os custos para a retirada do visto e da viagem internacional, de acordo com os limites estabelecidos pelos Consulados.
- **2.4** Todos os participantes receberão do Departamento de Estado dos Estados Unidos da América cobertura médica, conforme especificação presente no Anexo I (Winter 2020 Study of the U.S. Institute for Student Leaders on Social Entrepreneurship).

3. RESPONSABILIDADES DA UFOP

- **3.1** A UFOP selecionará 1 (um) estudante de graduação e encaminhará sua indicação para o Escritório da Representação Diplomática dos Estados Unidos em Belo Horizonte, que será responsável por receber as indicações de todo o estado e selecionar 2 (dois) candidatos de Minas Gerais para a seleção nacional.
- **3.2** Fornecer orientações gerais sobre o Programa, bem como instruir os interessados sobre questões relativas a este Edital.
- **3.3** Encaminhar a indicação do estudante selecionado pela UFOP para o Escritório da Representação Diplomática dos Estados Unidos em Belo Horizonte, o que não significa garantia de vaga na seleção nacional.

4. REQUISITOS BÁSICOS

- **4.1** Ser aluno de graduação, regularmente matriculado na UFOP, e estar cursando entre o primeiro ano (a partir do segundo período) e o terceiro ano da graduação.
- **4.2** Ter entre 18 e 25 anos.
- **4.3** Possuir proficiência comprovada em inglês.
- **4.4** Permanecer matriculado por pelo menos um semestre acadêmico após o período do Programa.
- **4.5** Apresentar um alto nível de desempenho acadêmico, indicado por meio de notas, prêmios ou cartas de recomendação de professores.
- **4.9** Não ter sido comtemplado em editais da CAINT com previsão de bolsas ou auxílios financeiros.

5. REQUISITOS PREFERENCIAIS

- **5.1** Ter interesse pela área de Empreendedorismo Social.
- **5.2** Demonstrar comprometimento com a comunidade e com atividades extracurriculares e de extensão.
- **5.3** Demonstrar grande capacidade de liderança e potencial nas atividades da Universidade e da comunidade.
- **5.4** Não ter tido uma experiência de viagem prévia nos Estados Unidos ou em outro país.
- **5.5** Apresentar grande interesse em aprender sobre os Estados Unidos.
- **5.6** Ser maduro, responsável, independente, confiante, de mente aberta, tolerante, atencioso e curioso.
- **5.7** Estar disposto e ser capaz de participar plenamente de um programa acadêmico intensivo, de serviços comunitários e de viagens educacionais.
- **5.8** Estar preparado para a vida no campus universitário, considerando o compartilhamento de acomodações e a adaptação às práticas culturais e sociais diferentes das de seu país de origem.

6. VAGAS PARA INDICAÇÃO

- **6.1** Será oferecida 01 (uma) vaga para indicação como representante da UFOP.
- **6.1.1** Após a indicação, o estudante passará por uma segunda seleção a nível estadual (2 vagas) e, posteriormente, por uma terceira seleção a nível nacional.
- **6.1.2** A UFOP apenas será responsável pela indicação do estudante selecionado, não participando das seleções a nível estadual e nacional.

7. INSCRIÇÃO

- **7.1** As inscrições serão recebidas exclusivamente por e-mail, até o dia **17 de setembro de 2019**, e deverão ser encaminhadas ao endereço <u>international@ufop.edu.br</u>, com o assunto "Inscrição Study of the U.S. Institutes (SUSI) for Student Leaders".
- **7.1.1** Inscrições com assunto diferente do especificado no subitem 7.1 ou enviadas fora do prazo não serão aceitas.
- **7.2** São documentos obrigatórios para inscrição:
- **7.2.1** Application Form (Anexo II), devidamente preenchido, conforme as instruções apresentadas no início do formulário, em formato PDF;
 - 7.2.2 Histórico Escolar, com certificação digital, emitido até quinze dias do ato de inscrição;
- **7.2.3** Certificado de proficiência em língua inglesa, com nível B1 ou superior no Quadro Europeu Comum de Referência para Línguas;
- **7.2.4** *Personal Statement*. Texto de até 750 palavras, conforme instruções contidas no Anexo II;
- **7.2.5** Reference Letter. Carta de recomendação escrita e assinada por um docente e/ou orientador do aluno, conforme instruções contidas no Anexo II.

8. DO PROCESSO DE SELEÇÃO

- 8.1 A seleção consistirá na avaliação da documentação enviada pelos candidatos.
- **8.2** A seleção se dará por meio da análise, pela Comissão Julgadora, dos requisitos básicos e preferências informados e devidamente comprovados pelo estudante em seu *Application Form* (Anexo II).
- **8.2** Será selecionado o estudante que obtiver a melhor avaliação na análise prevista no item 8.2.
- **8.3** O resultado será divulgado no dia **20 de setembro de 2019**, até às 18h, no endereço eletrônico https://www.caint.ufop.br.

WINTER 2020 STUDY OF THE U.S. INSTITUTE FOR STUDENT LEADERS ON SOCIAL ENTREPRENEURSHIP

Summary:

The US Department of State and the Public Affairs Section of the US Embassy in Brazil are pleased to invite candidate nominations for a winter **2020 Study of the United States Institute (SUSI) for Student Leaders** on the topic of **Social Entrepreneurship**. Program dates are **January 11 to February 15, 2020**. The program will be conducted in **English** and will be hosted at **the Institute for Training and Development (ITD)** in Amherst, Massachusetts.

1. Program Description:

Study of the U.S. Institutes (SUSIs) for Student Leaders are intensive short-term academic programs whose purpose is to provide groups of undergraduate student leaders with a deeper understanding of the United States while simultaneously enhancing their leadership skills. The five-week Institutes will consist of a balanced series of seminar discussions, readings, group presentations, and lectures. The coursework and classroom activities will be complemented by educational travel, site visits, leadership activities, and volunteer opportunities within the local community. The Institutes will include an academic residency component of approximately four weeks and a domestic study tour of approximately one week. During the academic residency, participants will also have the opportunity to engage in educational and cultural activities outside of the classroom.

The **four-week academic residency** will provide participants with an overview of how entrepreneurial skills can address social issues. The Institute will review the development, history, challenges, and successes of social enterprises and community leaders, in the United States and globally. The program will give participants a foundation in how to employ entrepreneurial skills to address social issues and will provide unique opportunities to meet with diverse community leaders and social entrepreneurs. The Institute will address topics such as organizational development and management, business ethics, negotiations, emerging markets and risk analysis, microfinance, corporate social responsibility, strategic business planning and innovation, and women and minorities in entrepreneurship. The academic residency will be complemented by an educational tour that will take participants to another area of the U.S. Throughout the Institute, participants will meet with local, state, private, and not-for-profit organizations working in the field. They will also be challenged to create follow up community projects to implement in their home communities upon returning to their countries of origin.

Another Institute for Student Leaders from the Western Hemisphere, this one on Women's Leadership and for different countries (Ecuador, Bolivia, Paraguay, and Peru), will take place concurrently at the University of Arizona in Tucson. Both programs will convene for two to four days in Washington, D.C., for the conclusion of the program.



OTHER ESSENTIAL PROGRAM INFORMATION:

Program Funding: The US Department of State will cover all participant costs, including program administration; domestic travel and ground transportation; book, cultural, mailing and incidental allowances; and housing and subsistence. ITD will arrange and pay for participants' international and visa travel costs and travel allowances within set limits and in coordination with consulates.

Housing and Meal Arrangements: Participants will reside at the ITD House, an 11 bedroom home situated in the center of Amherst, MA and a 10-minute walk from the Amherst College campus. Most meals will be provided at the Amherst College dinning commons, though some meals will be provided by the program, and participants will also receive per diem that they can use to dine at local restaurants. Care will be taken to ensure that any special requirements regarding diet, daily worship, housing, and medical care are satisfied.

Health Benefits: All participants will receive the Department of State's coverage of \$100,000 with a \$25 co-pay per medical visit and \$75 co-pay per emergency room visit for the duration of the program. Pre-existing conditions are not covered. Information on the health benefit program may be found online at usdos.sevencorners.com.

Program Requirements and Restrictions: Participants are expected to fully participate in the academic program. They should attend all lectures and organized activities, and complete assigned readings. Candidates should be made aware that the Institute is very intensive and that there will be little time for personal pursuits unrelated to the program.

Under no circumstances are participants allowed to arrive in the U.S. prior to the start date of the Institute or remain in the U.S. after its end date. Similarly, participants will not be permitted to leave the Institute to visit relatives or friends while in the United States. If a relative or friend wishes to visit them, it will be addressed on a case by case basis in consultation with the ECA program officer and the host institution. Participants are required to return to their home countries immediately following the end of the Institute(s).

Violations of program rules, host institution rules, or local, state or federal laws can be grounds for immediate dismissal from the program. It is important that these requirements and restrictions be made clear to all candidates before nominations are submitted.

English Language Ability: English Language knowledge and/or proficiency are required to participate in this program. All candidates must be proficient in English so that they can actively participate in the academic program.

CANDIDATE DESCRIPTION AND QUALIFICATIONS:

The participants are expected to be **highly motivated first through third year undergraduate students from colleges, universities, and other institutions of higher education**, who demonstrate leadership



through academic work, community involvement, and extracurricular activities. Their fields of study will be varied and may include the sciences, social sciences, humanities, education, business, and other professional fields. Emphasis should be made on recruiting participants from non-elite backgrounds, from both rural and urban areas, and with little or no prior experience in the United States or elsewhere outside their home country. In addition, recruitment of participants should include historically underserved, indigenous groups, Afro-Latinos, disadvantaged groups, individuals with disabilities, and ethnic minority communities.

Candidates nominated for this program will:

- be proficient in English;
- be interested in the topic of Social Entrepreneurship;
- be between 18 and 25 years of age;
- have at least one semester left of their undergraduate studies, and therefore be committed to return to their home universities following completion of the program;
- demonstrate strong leadership qualities and potential in their university and community activities;
- indicate a serious interest in learning about the United States;
- have a sustained high level of academic achievement, as indicated by grades, awards, and teacher recommendations;
- demonstrate commitment to community and extracurricular university activities;
- have little or no prior study or travel experience in the United States or elsewhere outside of their home country;
- be mature, responsible, independent, confident, open-minded, tolerant, thoughtful, and inquisitive;
- be willing and able to fully participate in an intensive academic program, community service, and educational travel; and,
- be comfortable with campus life, prepared to share living accommodations, and able to make adjustments to cultural and social practices different from those of their home country.

FREQUENTLY ASKED QUESTIONS:

- a. How much free time will a participant have during the program? There will be some free time during the program. However, nominees MUST understand that this is an intensive academic program and they are expected to fully participate in all lectures, activities, site visits, and scheduled events.
- b. **If a nominee has relatives in the U.S., would he/she have time to see them?** Participants will **NOT** be allowed to leave the Institute to visit relatives or friends. Occasionally it is possible for a relative or friend to visit the participant on a specific day designated by the



host institution if the schedule permits. These situations will be addressed on a case by case basis in consultation with the ECA program officer and the host institution.

- c. Can a participant arrive early/late or stay after the Institute? No. Participants who choose to travel to the United States on a Study of the U.S. Institute are required to abide by the terms and conditions of the program. These terms state clearly that student leaders may NOT arrive in the United States before the program start date or remain in the country after the close of the Institute.
- d. **Can a graduate student participate in this Institute?** No. Study of the U.S. Institutes for Student Leaders are designed **exclusively for undergraduate students** with at least one remaining semester of study.
- e. **Can a participant miss one part or component of the Institute?** No. All participants are expected to participate in all scheduled lectures, events, site visits, trips, and activities.
- f. How much money will participants need to bring for the program? The Study of the U.S. Institutes cover all basic costs of an individual's participation including transportation, lodging, and meals. Generally, host institutions provide for meals through a combination of a cafeteria meal plan, a pre-loaded debit card for use at local restaurants, and/or a cash allowance to permit participants to purchase food for cooking. Information on housing and meal arrangements will be provided by the host institution six weeks prior to the start of the Institute. Other than the meal stipend mentioned above, participants should not expect to receive any spending money from the Institute. Participants should bring their own spending money if they wish to purchase souvenirs or other items during their time in the United States.
- g. Are participants permitted to smoke during the Institute? Yes. However, participants should be aware that many places in the United States now prohibit smoking. Smoking in such places could be considered a violation of the law. Some places that may prohibit smoking are university housing, classrooms, office buildings, restaurants, public parks, and other locations. Smoking laws will vary from location to location so participants who smoke should look for designated smoking areas.
- h. Will applicants with disabilities be considered? Yes, the Study of the U.S. Branch welcomes nominations for individuals with disabilities. We are committed to working with our Institute hosts to arrange reasonable accommodations for all participants. While notification of a disability will not negatively impact selection, we ask that you identify disabilities during the nomination process so that we can begin working with our Institute hosts to ensure appropriate accommodations.
